

  - ✓ Active projects in energy, finance, urban and rural development, water & sanitation, health, education, social protection, climate, etc.








#### Ongoing IPF Operations in Anglophone Africa (~\$39b)






## IPF pipeline in Anglophone Africa (~\$14.75b)






## Classification of 108No. Contracts awarded to RSA firms and individuals January 2018-September 2019

Classification of 108No. Contracts awarded to RSA firms and Individuals on WBG Financed Projects from 1 January 2018 to 30 September 2019






## Distribution of contracts awarded to RSA firms & Individuals in 25 countries Jan 2018- Sept 2019

- » Firms need to understand strategic direction of WBG and the Countries we work with (Country Partnership Framework / National Development plans)
- » Firms need to know where to obtain information (www.worldbank.org / country websites for Ministries of Finance/ Development Planning / Infrastructure / Procurement Authorities.
- » Firms must understand the basics of procurement and consultant selection: key steps, types of documents required at each step, procedures for seeking clarifications, complaints resolution methods, how to escalate when dissatisfied.
